Privacy Policy

This privacy policy and statement ("**Privacy Policy**") describes the information Bounce Back Recycling ("**BBR**") will collect from time to time in order to accommodate the provision of our services to you, related information requests and our intended use of that information.

The BBR respects your right to privacy and will not collect any personal information about you without your consent. BBR is committed to protecting your personal data, and we endeavour to ensure any personal data you provide to us remains private and is used for the purposes outlined in this Privacy Policy.

We respect your right to privacy and will not collect any personal information about you without your consent.

By viewing or using this website you accept and agree to all of the provisions of this Privacy Policy.

Data Collection

For the purpose of ensuring the smooth operation of the BBR's service (the "Service"), the processing of your payments for that Service as well as any queries and/or other information requests you may have, we will require and collect from you such personal data as your name, address, telephone number, email address, credit card information, user IP address in circumstances where they have not been deleted, clipped or anonymised and other contact and billing information. Such information is only collected from you if you voluntarily submit it to us, e.g. by sending us an email, providing the information over the phone, social media or on our website.

Purpose

The personal data you provide to us will be used for the following general purposes:

Disclosure

This includes exchanging information with other companies and organisations for the purposes of fraud protection and credit risk reduction.

We may also share aggregated, non-personally identifiable information and de-identified data with our partners or others.

Data Storage and retention

Your personal data is stored by BBR on its servers, and may be stored on the servers of a cloud-based management services BBR engages, located in the EEA. We may transfer and maintain your data on servers located outside of the European Economic Area (EEA) but only in or to such countries outside of the EEA which have been approved by the European Union as providing adequate levels of data protection.

We will only retain your personal data for as long as necessary to fulfil the purposes we collected it for, including the purposes of satisfying any legal, account, or reporting requirements.

Security

We will take commercially reasonable efforts to ensure that your data is held on secure servers and that it has appropriate security measures in place to prevent unauthorised access to, or unauthorised alteration, disclosure or destruction of, your data and against their accidental loss or destruction. Please be aware, however, that despite our efforts, no security measures are perfect or impenetrable and no method of data transmission can be guaranteed as entirely secure.

We make no representations or warranties as to the security of any information transmitted to or by us over the Internet.

Data Subject Rights

You have certain rights in relation to your personal data including:

- the right to find out what personal data we hold on you and request access to it;
- the right to have your personal data updated, amended or removed for our database;
- the right to object to the use of your personal data or restrict access to it; and
- the right to request that we send your personal data to a third party.

It is important that the personal data we hold is accurate and current. Please inform us of any changes in your personal data, and in accordance with our obligations under the Data Protection Legislation we will update or delete your personal data accordingly. It is always your responsibility to keep your personal data up to date.
